5 – FIRE-FIGHTING MEASURES

Prevention: Keep away from heat, sparks and flame. Avoid the formation of dust due to the risk of explosion in the presence of

electrical sparks and static discharge.

Suitable Extinguishing Media: CO2, powder or water. Fight larger fires with water or alcohol-resistant foam.

<u>Cleaning methods</u>: If the product is in liquid form, stop it from entering the drainage system. In case material

released or spilled, vacuum spill. Appropriately absorb any spills with inert material and dispose of properly. Avoid the formation of dust. After picking up the product, rinse the area

and materials with water.

7 – HANDLING AND STORAGE

Precaution for handling: Avoid contact and inhalation of dust. See also § 8 below. Do not eat or drink during the work.

Avoid static electricity. The dust can form an explosive mixture with air. Storage conditions: The containers should always be tightly closed.

For local indication: Store in original sealed packages, in a cool dry place (off the floor) in an odour-free environment.

Protection: Wear protective mask (P2 filter) in case of excessive dusts

Protection of hands: Use waterproof protective gloves in case of sensibility and in case of excessive dusts.

Eye protection: Wear safety glasses in case of excessive dusts.

Skin Protection: Wear protective clothes.
